



## TAMILNADU MEDICAL COUNCIL ADVISORY – # 13, ON LIFE CERTIFICATE

Life Certificate is an Identity Certificate to confirm if the person is alive – for Pensioners, and registration purpose, etc. **(Formats Attached)**

1. The purpose of issuing the certificate is to know the said person is alive. (Registration department and for pensioners)
2. This is NOT a medical certificate.
3. This certificate has to be issued by a Gazetted Officer, if the Certifying Officer personally knows the person.
4. If the person is personally known, then the Life Certificate can be issued, consisting of Identification marks/ Signature / LTI of the person and affix passport size photograph with signature.
5. **Caution:** On many occasions, an impersonator fixes his own photo with the name of a dead person or another live person and walks in with fake IDs. He forges the signatures and get the Certificate.
6. This shall not be issued to unknown persons brought by known persons like relatives and friends – with or without IDs.
7. Common crimes occur in those claiming for registration of properties.

Hence RMPs are advised not to issue Life Certificates to unknown person. (as for Conduct certificate)

**This certificate shall be attested by any one the following authorities:**

1. Revenue Inspector of the area where the Pensioner / Family Pensioner resides.
2. Tahsildars and Deputy Tahsildars of Revenue Department.
3. Gazetted Officers of the State Government.
4. Gazetted Officers of the Central Government.
5. Bank Managers of the Branch where the Pensioners / Family Pensioners receive pension / family pension under Pension Pilot Scheme.
6. Pensioners / Family Pensioners staying abroad are permitted to produce this certificate with Identification Details only signed by a Magistrate, a Notary, a Banker or a Diplomatic Representative of India that the Pensioner / Family Pensioner is alive.
